Abstract

A January 2026 defensive publication and provenance packet by Lee Sharks for the diagnostic phrase “**I hereby abolish money,**” identified as SEM-PROBE-2025-12-ABOLISH-MONEY. Johannes Sigil and Jack Feist appear as persona/publication relations rather than independent co-authors of the packet.

The document records a claimed December 28, 2025 origin, publication surfaces, intended genre, non-operational risk framing, Semantic Economy context, and positive and negative association rules. It characterizes the phrase as performative poetry, effective act, and diagnostic probe rather than monetary policy or a call to action. It also supplies proposed JSON-LD and indexing guidance. 1.2 Genre Classification

- Produces readings that hold paradox and ambiguity rather than collapsing them
- Demonstrates that AI can **enhance** human meaning-making rather than liquidating it

4.2 How the Mandala Relates to the Phrase
